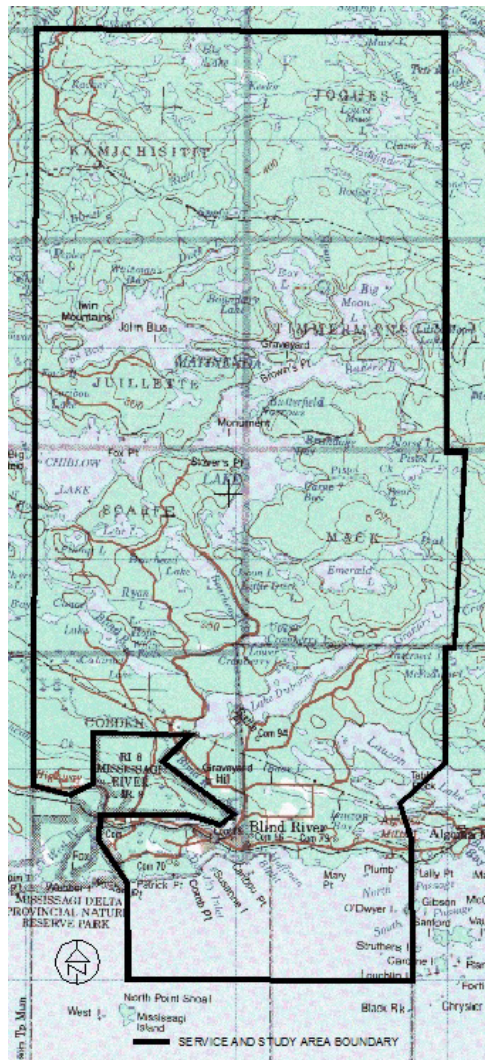


Notice of Submission of Terms of Reference  
Town of Blind River  
Municipal Waste Management Plan

As part of the planning process for the Town of Blind River Waste Management Plan, a terms of reference was submitted to the Ministry of the Environment for review as required under the *Environmental Assessment Act*. If approved, the terms of reference will serve as a framework for the preparation and review of the environmental assessment for the proposed undertaking.

The Town of Blind River has initiated the Environmental Assessment Planning Process to identify the preferred method of addressing decreasing landfill capacity and disposal beyond current allowable limits, to provide the Town with a long-term waste management plan. Remaining landfill capacity has been estimated to be less than 10 years. The undertaking will address non-hazardous residential, industrial, commercial and institutional (IC&I), construction and demolition (C&D), biosolid and iron sludge wastes generated within the Study Area which coincides with the Town's municipal boundaries (shown generally below).
